Element 2: a ridden component with all exhibits doing an individual workout under the saddle judge  
Element 3: a led component with the exhibit unsaddled and judged for conformation and type by the conformation/type judge

#### Workouts

Placings

Class placings will go to 6th place.

#### Scoring

Marks are awarded in the classes only (not the championship) being 50% Manners and Way of Going (ridden) and 50% on Conformation and Type (led). In the event of a tie, the exhibit with the highest Manners and Way of Going (ridden) score will be the winner.

#### Prize money

The prize money for each qualifying class will be: Champion - \$100; Reserve Champion - \$50

The prize money for the National Final class will be: Champion - \$5,000; Runner Up: \$1,000; 3rd - \$100; 4th - \$100; 5th - \$100

#### Qualifying

The two highest placed horse/pony in each qualifying class will qualify for the National Final in March 2022. In the event that the two highest placed horse/ponies have already qualified, qualification will go no lower than third place. A horse/pony may only qualify once but can continue to compete in subsequent qualifiers after they have gained their qualification.

#### Membership

The Owner/Exhibitor of the horse/pony must be a financial member of the WP&CS of Australia and the horse/pony must be registered in the name of the Owner/Exhibitor.

Non Member handlers and helpers (of the Welsh Pony & Cob Society) must sign the relevant Liability Waiver Form and this must accompany entries. Welsh Members who have not included Liability Waiver on reverse of Membership must sign the Liability Wavier Form and this must accompany entries.

Exhibits WILL NOT be accepted into the rings without green wrist bands and exhibit number – to be collected on the day.

<sup>2</sup> Activities includes all activities and services ancillary to or associated with the named Activity, both before and after the Activity, including transportation to and from the location of the Activity whether provided by the Provider or not, briefings, inductions, training, and the provision of information in all manuals, safety guidelines and other documentation provided to or made available to the Participant with respect to the Activity, familiarisation with clothing or equipment and methods of operation of equipment and the wearing and removal of any clothing or equipment associated with the Activity. Unless otherwise specified, a reference to an Activity is a reference to a recreational service or a recreational activity as defined in relevant legislation referred to herein.

## Participant's Warranties

I agree that if I suffer any injury or illness, the Provider may provide evacuation, first aid and/or medical treatment at my expense and that my acceptance of these terms and conditions constitutes my consent to such evacuation, first aid and/or medical treatment.

I declare that I have not consumed any alcohol or mind altering substance, or medication that may impact my judgement or physical capacity, before or at the time of engaging in the Activities.

## Exclusion of liability
